The parties shall attempt in good faith to resolve any dispute arising out of, or relating to, this agreement promptly by negotiating between executives who have authority to settle the controversy and who are at a higher level of management than the persons with direct responsibility for the administration of this contract. Any person may give the other party written notice of any dispute not resolved in the normal course of business. Within 15 days after delivery of the notice, the receiving party shall submit to the other a written response. The notice of the response shall include: (A) a statement of the parties position and a summary of arguments supporting the position, and (B) the name and title of the executive who will represent that party and any other person who will accompany the executive. Within 30 Days after delivery of the initial notice, the executives of both parties shall

meet at a mutually acceptable time and place, and thereafter as often as they reasonably deem necessary, to attempt to resolve the dispute. All reasonable requests for information made by one party to the other will be honored.

Woodbean Trading Company payment terms are NET 14 days. The payment terms are calculated from the date of the invoice. If credit privileges are extended to Applicant, payments will be tendered in accordance with WTC's selling terms of thirty (30) days from the date of statement.

Nothing contained in this application shall obligate WTC to extend credit privileges to Applicant. WTC may extend or refuse credit privileges to the applicant or increase the amount of credit privileges available to Applicant at any time, in its sole discretion.
